14 of April (23:59 GMT)	Deadline for receiving information, under the terms of number 6 of article 23-C of the Portuguese Securities Code, from shareholders who, in their professional capacity, hold shares in their own name but on behalf of clients, may vote their shares in different ways.
18 of April (23:59 GMT)	Deadline for receiving written voting papers sent by post. Deadline for receiving proxy letters
